

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0484

Affirmed
Request to Reopen Allowed
Ineligible for Benefits Weeks 9-25 Through 28-25

PROCEDURAL HISTORY: On March 4, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not complete his registration for work and was ineligible for benefits beginning February 23, 2025 (decision # L0009548639). Claimant filed a timely request for hearing. On May 6, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 21, 2025. On May 21, 2025, claimant failed to appear for the hearing, and ALJ Enyinnaya issued Order No. 25-UI-292906, dismissing claimant's request for hearing because he failed to appear.

On June 10, 2025, claimant filed a timely request to reopen the May 21, 2025 hearing. On July 15, 2025, ALJ Christon conducted a hearing, and on July 23, 2025 issued Order No. 25-UI-298503, allowing claimant's request to reopen and modifying # L0009548639 by concluding that claimant was ineligible for benefits for the weeks from February 23 through July 12, 2025 (weeks 9-25 through 28-25).¹ On August 10, 2025, claimant filed an application for review of Order No. 25-UI-298503 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument in making this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-298503's findings of fact, reasoning in allowing claimant's request to reopen the May 21, 2025 hearing and concluding that claimant was ineligible benefits for weeks 9-25 through 28-25 because he did not complete his registration for work as required by the Department. Order No. 25-UI-298503 is **adopted**. See ORS 657.275(2).

¹ Although Order No. Order No. 25-UI-298503 said it affirmed decision # L0009548639, it modified that decision by changing the weeks of ineligibility to the weeks from February 23 through July 12, 2025 (weeks 9-25 through 28-25). Order No. 25-UI-298503 at 7.

DECISION: Order No. 25-UI-298503 is affirmed.
