

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0496

Affirmed
Disqualification

PROCEDURAL HISTORY: On July 2, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning March 2, 2025 because she quit working for the employer without good cause (decision # L0011683676).¹ Claimant filed a timely request for hearing. On July 29, 2025, ALJ Parnell conducted a hearing, and on July 30, 2025 issued Order No. 25-UI-299084, affirming decision # L0011683676. On August 13, 2025, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider the written argument claimant included with her application for review because she did not state that they provided a copy of her argument to the employer as required by OAR 471-041-0080(2)(a) (May 13, 2019).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-299084's findings of fact, reasoning, and conclusion that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective March 2, 2025, until requalified under Department law. Order No. 25-UI-299084 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-299084 is affirmed.

¹ Decision # L0011683676 stated that claimant was denied benefits from March 2, 2025 to May 30, 2026. However, decision # L0011683676 should have stated that claimant was disqualified from receiving benefits beginning March 2, 2025 and until she earned four times her weekly benefit amount. See ORS 657.176.
