EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0545

Application for Review Dismissed No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 5, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and therefore was disqualified from receiving unemployment insurance benefits effective March 16, 2025 (decision # L0011120038). Claimant filed a timely request for hearing. On August 7, 2025, ALJ Murdock conducted a hearing at which the employer failed to appear. On August 13, 2025, ALJ Murdock attempted to issue a hearing order in the matter, Order No. 25-UI-300502, but, due to a systems error, the order did not attach and only a certificate of mailing was issued. On August 27, 2025, claimant filed an application for review of Order No. 25-UI-300502 with the Employment Appeals Board (EAB).

On September 11, 2025, the Office of Administrative Hearings (OAH) sent a letter to the parties advising that OAH had inadvertently failed to mail Order No. 25-UI-300502 to the parties previously and enclosed a new hearing order, Order No. 25-UI-303507, which reversed decision # L0011120038 by concluding that claimant had voluntarily quit work with good cause and was not disqualified from receiving benefits based on the work separation. EAB is treating claimant's application for review of Order No. 25-UI-300502 as an application for review of Order No. 25-UI-303507.

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 25-UI-303507 presents no justiciable controversy and is dismissed.

Claimant's August 27, 2025 application for review of Order No. 25-UI-300502, which is being treated as an application for review of Order No. 25-UI-303507, seeks review of an order that was fully favorable to claimant. Oregon courts follow the principle that a review on appeal may only be provided for justiciable controversies. *See, e.g., Gortmaker v. Seaton*, 252 Or. 440, 442, 450 P.2d 547 (1969). A justiciable controversy exists when the interests of the parties to the action conflict with each other, and

However, decision # L0011120038 should have stated that claimant was disqualified from receiving benefits beginning Sunday, March 16, 2025 and until he earned four times his weekly benefit amount. *See* ORS 657.176.

the appeal will have some practical effect on the rights of the parties to the controversy. *Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). To show a practical effect on their rights, an appellant must seek "substantive relief" through their appeal. *Krisor v. Henry*, 256 Or. App. 56, 300 P.3d 199 (Or. Ct. App. 2013).

Claimant did not assign error to any portion of Order No. 25-UI-303507, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Because EAB's review of this matter could not provide substantive relief to the appellant, such review would have no practical effect on the appellant's rights. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. Because the case before EAB presents no justiciable controversy, the application for review of Order No. 25-UI-303507 is dismissed and Order No. 25-UI-303507 remains undisturbed.

DECISION: The application for review filed August 27, 2025 is dismissed. Order No. 25-UI-303507 remains undisturbed.
