EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0581

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On October 12, 2021, the Oregon Employment Department (the Department) served notice of a wage and potential benefit report (WPBR) concluding that claimant had a monetarily valid claim for Pandemic Emergency Unemployment Compensation (PEUC) benefits with a weekly benefit amount (WBA) of \$323 and initial maximum benefit amount of \$4,199. On October 22, 2021, the October 12, 2021 WPBR became final without claimant having filed a request for hearing. On September 3, 2025, claimant filed a late request for hearing. ALJ Kangas considered the request, and on September 16, 2025, issued Order No. 25-UI-303892, dismissing the request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 30, 2025. Claimant did not file an appellant questionnaire response. On October 2, 2025, claimant filed an application for review with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review, has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.²

FINDING OF FACT: (1) The October 12, 2021 WPBR, mailed to claimant's address of record on file with the Department on that date, stated, "This report becomes final unless you request redetermination of the report or request a hearing within 10 days following the date mailed or delivered. . . The time

limit for requesting a hearing may be extended for good cause." Exhibit 1 at 2. Claimant filed a request for hearing on September 3, 2025.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.266(5) states that the Department's initial or amended determination on a claim for benefits becomes final unless a party files a request for hearing within 10 days after the date the determination is mailed. ORS 657.875 states that the 10-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) states that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake and defines "reasonable time" as seven days after those factors ended.

The request for hearing on the October 12, 2021 WPBR was due by October 22, 2021. Claimant filed his request for hearing on September 3, 2025, and therefore the request was late. The information included in claimant's application for review suggested that he disagreed with the WBA and maximum benefit amount, as well as with being denied benefits for reasons unrelated to the WPBR.³ However, claimant did not describe the circumstances that prevented him from filing the request for hearing by the October 22, 2021 deadline. Accordingly, claimant has not shown good cause to extend the filing deadline, and his late request for hearing is dismissed.

DECISION: Order No. 25-UI-303892 is affirmed.
