

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0586

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 23, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective May 11, 2025 (decision # L0012014849).¹ Claimant filed a timely request for hearing. On September 11, 2025, ALJ Goodrich conducted a hearing and issued Order No. 25-UI-303434, modifying decision # L0012014849 by concluding that claimant was disqualified from receiving benefits effective May 18, 2025. On October 1, 2025, Order No. 25-UI-303434 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 6, 2025, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant included with his application for review, which has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

FINDING OF FACT: Order No. 25-UI-303434, mailed to claimant on September 11, 2025, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 25-UI-303434 at 4. Order No. 25-UI-303434 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before October 1, 2025 to be timely.”

¹ Decision # L0012014849 stated that claimant was denied benefits from May 11, 2025 to October 25, 2025. However, decision # L0012014849 should have stated that claimant was disqualified from receiving benefits beginning May 11, 2025 and until she earned four times her weekly benefit amount. See ORS 657.176.

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 25-UI-303434 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-303434 was due October 1, 2025. Because claimant did not file his application for review until October 6, 2025, the application for review was late. Claimant included a written statement with the application for review. Claimant’s written statement stated that claimant received a copy of Order No. 25-UI-303434, which was sent on September 11, 2025 “over a week later.” EAB Exhibit 1 at 1. Claimant added “Also, I have been experiencing computer/printer issues and am not much of a ‘tech guy’” EAB Exhibit 1 at 1. The rest of the statement did not further explain why claimant filed a late application for review, but instead related to the merits of claimant’s work separation and related text messages. EAB Exhibit 1. Given that the application for review was not due until October 1, 2025, and claimant received the decision approximately one week after it was sent on September 11, 2025, claimant had ample time to file a timely application for review. Although claimant is not a “tech guy,” claimant was not precluded from timely filing an application for review because of a computer or technology-related reason. Rather, claimant submitted a handwritten argument and mailed his application for review via postal service. Accordingly, claimant did not show good cause for the late application for review, and his late application for review is dismissed.

DECISION: The application for review filed October 6, 2025 is dismissed. Order No. 25-UI-303434 remains undisturbed.
