EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0588

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 9, 2023, the Oregon Employment Department served notice of an administrative decision concluding that claimant willfully underreported earnings and failed to report a work separation to obtain \$3,791 in benefits to which she was not entitled and must repay, and was assessed a \$1,137.30 monetary penalty and disqualified for 24 weeks of future benefits (overpayment decision). On August 29, 2023, the overpayment decision became final without claimant having requested a hearing. On August 22, 2025, claimant filed a late request for hearing. ALJ Kangas considered the request, and on September 16, 2025 issued Order No. 25-UI-303953, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 30, 2025. On October 6, 2025, Order No. 25-UI-303953 became final without claimant having responded to the appellant questionnaire or filed an application for review of Order No. 25-UI-303953 with the Employment Appeals Board (EAB). On October 7, 2025, claimant filed a late application for review of Order No. 25-UI-303953 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's late application for review, has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit(s) will remain in the record.

FINDING OF FACT: Order No. 25-UI-303953, mailed to claimant on September 16, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-303953 at 2. Order No. 25-UI-303953 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than October 6, 2025."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-303953 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-303953 was due October 6, 2025. Because claimant did not file her application for review until October 7, 2025, the application for review was late. EAB Exhibit 1. Claimant included a written statement with the application for review. EAB Exhibit 1. However, the written statement only addressed the lateness of claimant's request for hearing on decision the overpayment decision. EAB Exhibit 1. The written statement did not describe circumstances preventing claimant from filing her application for review of Order No. 25-UI-303953 on time. Accordingly, claimant did not show good cause for the late application for review, and her late application for review is dismissed.

DECISION: The application for review filed October 7, 2025 is dismissed. Order No. 25-UI-303953 remains undisturbed.
