EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0597

Affirmed
Late Request to Reopen Denied
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On March 11, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to complete the Department's identification requirements and was not eligible for benefits beginning March 2, 2025 (decision # L0009795586). On March 18, 2025, the Department served notice of an administrative decision concluding that claimant did not complete the Department's work registration requirements and was not eligible for benefits beginning March 2, 2025 (decision # L0010017639). On March 31, 2025, decision # L0009795586 became final without claimant having filed a request for hearing. On April 7, 2025, decision # L0010017639 became final without claimant having filed a request for hearing. On April 18, 2025, claimant filed a late request for hearing on decision # L0010017639. On May 23, 2025, claimant filed a late request for hearing on decision # L0009795586.

ALJ Kangas considered claimant's request on decision # L0010017639, and on April 29, 2025 issued Order No. 25-UI-290950, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 13, 2025. On May 6, 2025, claimant filed a timely request to the appellant questionnaire. On May 23, 2025, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 25-UI-290950 was vacated and that a new hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # L0010017639.

ALJ Kangas considered claimant's request for hearing on decision # L0009795586, and on June 2, 2025 issued Order No. 25-UI-293696, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 16, 2025. On June 9, 2025, claimant filed a timely response to the appellant questionnaire.

On June 10, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 26, 2025 on whether to allow claimant's late requests for hearing and, if so, the merits of decisions # L0009795586 and # L0010017639. On June 26, 2025, claimant failed to appear at the hearing and ALJ Christon issued Order Nos. 25-UI-296015 and 25-UI-296016, dismissing claimant's

requests for hearing on decisions # L0009795586 and L0010017639 for failing to appear. On July 16, 2025, Order Nos. 25-UI-296015 and 25-UI-296016 became final. On August 26, 2025, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on September 25, 2025 issued Order Nos. 25-UI-304896 and 25-UI-304895, denying the request and leaving Order Nos. 25-UI-296015 and 25-UI-296016 undisturbed. On October 3, 2025, claimant filed applications for review of Order Nos. 25-UI-296015 and 25-UI-296016 with the Employment Appeals Board (EAB).

EAB combined its review of Orders No. 25-UI-304896 and 25-UI-304895 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2025-EAB-0597 and 2025-EAB-0596).

WRITTEN ARGUMENT: EAB considered claimant's written argument.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order Nos. 25-UI-304896 and 25-UI-304895's findings of fact, reasoning, and denial of claimant's late request to reopen, leaving Order Nos. 25-UI-296015 and 25-UI-296016 dismissing claimant's late requests for hearing undisturbed. Order Nos. 25-UI-304896 and 25-UI-304895 are **adopted**. *See* ORS 657.275(2).

DECISION: Order Nos. 25-UI-304896 and 25-UI-304895 are affirmed. Order Nos. 25-UI-296015 and 25-UI-296016 remain undisturbed.
