

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0620

Affirmed
Late Request to Reopen Denied

PROCEDURAL HISTORY: On November 20, 2024, the Oregon Employment Department (the Department) served notice of administrative decisions concluding that claimant filed late claims for benefits for the weeks of September 22 to 28, 2024; September 29 to October 5, 2024; October 6 to 12, 2024; October 13 to 19, 2024; October 20 to 26, 2024; and October 27 to November 2, 2024 (decisions # L0007314685; L0007336198, L0007281838; L0007331183, L0007364472, and L0007396856 respectively) and was denied benefits for those weeks. Claimant filed timely requests for hearing on those decisions.

On May 20, 2025, the Office of Administrative Hearings (OAH) mailed a notice of a consolidated hearing scheduled for June 3, 2025. On June 3, 2025, claimant failed to appear at the hearing, and on June 4, 2025 ALJ Monroe issued Orders No. 25-UI-294062, 25-UI-294069, 25-UI-294070, 25-UI-294067, 25-UI-294065, and 25-UI-294064 dismissing claimant's requests for hearing on decisions # L0007314685, L0007336198, L0007281838, L0007331183, L0007364472, and L0007396856 for failure to appear. On July 28, 2025, claimant filed a late request to reopen the hearing.

On September 29, 2025, ALJ Monroe conducted a hearing, and on October 9, 2025 issued Orders No. 25-UI-306693, 25-UI-306685, 25-UI-306684, 25-UI-306689, 25-UI-306691, and 25-UI-306692 denying claimant's request to reopen the June 3, 2025 hearing as late and without good cause. On October 15, 2025, claimant filed timely applications for review of those orders with the Employment Appeals Board (EAB).

EAB combined its review of Orders No. 25-UI-306693, 25-UI-306685, 25-UI-306684, 25-UI-306689, 25-UI-306691, and 25-UI-306692 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in sextuplicate (EAB Decisions 2025-EAB-0622, 2025-EAB-0618, 2025-EAB-0617, 2025-EAB-0619, 2025-EAB-0620, and 2025-EAB-0621).

ADOPTION OF HEARING ORDERS: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Orders No. 25-UI-306693, 25-UI-

306685, 25-UI-306684, 25-UI-306689, 25-UI-306691, and 25-UI-306692's findings of fact, reasoning, and denial of claimant's request to reopen the June 3, 2025 hearing. Orders No. 25-UI-306693, 25-UI-306685, 25-UI-306684, 25-UI-306689, 25-UI-306691, and 25-UI-306692 are **adopted**. See ORS 657.275(2).

DECISION: Order Nos. 25-UI-306693, 25-UI-306685, 25-UI-306684, 25-UI-306689, 25-UI-306691, and 25-UI-306692 are affirmed.
