

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0623-R-R

Request for Reconsideration Denied

PROCEDURAL HISTORY AND FINDINGS OF FACT: On August 13, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective June 8, 2025 (decision # L0012303279). Claimant filed a timely request for hearing. On October 10, 2025, ALJ Parnell conducted a hearing, and on October 14, 2025 issued Order No. 25-UI-307069, modifying decision # L0012303279 by concluding that claimant quit work without good cause and was disqualified from receiving benefits effective July 6, 2025. On October 16, 2025, claimant filed an application for review with the Employment Appeals Board (EAB). On November 19, 2025, EAB issued EAB Decision 2025-EAB-0623, affirming Order No. 25-UI-307069. On December 2, 2025, claimant filed a request for reconsideration with EAB. On January 9, 2026, EAB issued EAB Decision 2025-EAB-0623-R, allowing claimant's request for reconsideration and following EAB Decision 2025-EAB-0623 on reconsideration. On January 13, 2026, claimant filed a request for reconsideration of EAB Decision 2025-EAB-0623-R with EAB. This decision is made under EAB's authority from ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration of EAB Decision 2025-EAB-0623-R is denied.

ORS 657.290(3) permits the Employment Appeals Board, in its discretion, to reconsider any past decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request will be dismissed unless it says that a copy of the request was given to the other parties, and unless it is filed within 20 days after the decision the party wants to be reconsidered was mailed. OAR 471-041-0145(2).

Claimant's January 13, 2026 request for reconsideration was filed within 20 days of the date EAB Decision 2025-EAB-0623-R was mailed, and stated that a copy of it was mailed to the employer. The request for reconsideration is therefore not subject to dismissal under OAR 471-041-0145(2).

However, the January 13, 2026 request for reconsideration asserted the same errors of fact or law that were addressed in EAB Decision 2025-EAB-0623-R, which allowed claimant's December 2, 2025 request for reconsideration of EAB Decision 2025-EAB-0623, and followed that decision on reconsideration. Further reconsideration of those alleged errors would not yield a different result. Claimant's disagreement with the findings of fact or conclusions of law in EAB Decision 2025-EAB-0623-R are therefore best addressed through appeal to the Court of Appeals, and information about claimant's appellate rights is noted below. Accordingly, claimant's request to reconsider EAB Decision 2025-EAB-0623-R is denied.

DECISION: Claimant's request for reconsideration of EAB Decision 2025-EAB-0623-R is denied. EAB Decision 2025-EAB-0623-R remains undisturbed.
