EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0624

Affirmed Ineligible Week 28-25

PROCEDURAL HISTORY: On July 15, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide identity verification information in accordance with the Department's rules and was ineligible for benefits from July 6 through 12, 2025 (week 28-25), and until the reason for the denial ended (decision # L0011873476). Claimant filed a timely request for hearing. On October 7, 2025, ALJ Logan conducted a hearing, and on October 10, 2025 issued Order No. 25-UI-306822, affirming decision # L0011873476 by concluding that claimant failed to provide identity verification information in accordance with the Department's rules and was ineligible for benefits for week 28-25. On October 16, 2025, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted written arguments on October 16 and 25, 2025. Claimant's arguments contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing. EAB considered any parts of claimant's argument that were based on the hearing record.

FINDINGS OF FACT: (1) On June 21, 2025, claimant filed an initial claim for unemployment insurance benefits via Frances Online. The Department determined that claimant had a valid claim for benefits.

(2) When claimant set up his Frances Online account, he requested electronic notifications from the Department.

- (3) On June 24, 2025, the Department uploaded a letter to claimant's Frances Online account informing claimant of several outstanding tasks on his claim that needed to be completed, including that he was required to verify his identity. The letter stated that the deadline for claimant to complete identity verification was July 8, 2025.
- (4) On July 2, 2025, claimant logged into his Frances Online account. While he was logged in, claimant viewed the June 24, 2025 letter but did not notice the identity verification requirement.
- (5) Claimant repeatedly attempted to call the Department for help in the period after he viewed the June 24, 2025 letter, but each time he called, he was placed on hold and could not connect with a representative.
- (6) The July 8, 2025 deadline passed without claimant having completed the identity verification task. Claimant claimed benefits for the week of July 6 through 12, 2025 (week 28-25). This is the week at issue.
- (7) The Department did not pay claimant for week 28-25 because he had not verified his identity. On July 15, 2025, the Department issued decision # L0011873476, concluding that claimant was denied benefits beginning week 28-25 because he had failed to verify his identity. The same day, claimant viewed the administrative decision via Frances Online.
- (8) Once claimant viewed decision # L0011873476 he understood that he needed to provide information to verify his identity and that he had been denied benefits because he had failed to do so. On July 18, 2025, claimant completed the identity verification requirement.

CONCLUSIONS AND REASONS: Claimant failed to provide identity verification information in accordance with the Department's rules and therefore was ineligible for benefits for week 28-25.

Under ORS 657.155(1)(b), in order to be eligible to receive benefits with respect to any week, an individual must make "a claim for benefits with respect to such week in accordance with ORS 657.260." ORS 657.260(1) provides that claims for benefits shall be filed in accordance with such regulations as the Department may prescribe. OAR 471-030-0025 (January 11, 2018) states:

- (1) With all claims, an individual shall furnish the Director with . . . information required for processing their claim. * * *
- (2) The claimant is required to furnish such information required for processing their claim within the time frame provided by the Director or an authorized representative of the Employment Department. * * *

* * *

The Department denied claimant benefits for week 28-25 because he failed to complete identity verification by the July 8, 2025 deadline. This deadline was set forth in the June 24, 2025 letter, which the Department uploaded to claimant's Frances Online account. Claimant viewed the letter on July 2, 2025, but did not notice the identity verification requirement. Claimant also tried to call the Department

for assistance many times in the period after he viewed the June 24, 2025 letter, but each time was placed on hold.

It is regrettable that claimant did not notice the identity verification requirement when he viewed the letter on his Frances Online account on July 2, 2025, and that he was unable to connect with a Department representative for assistance. Nevertheless, the record shows that the Department provided claimant notification of the identity verification requirement and of the deadline to comply. OAR 471-030-0025 contains no good cause exceptions for failing to furnish information within the time frame the Department provides. Because claimant failed to complete the identity verification requirement by the deadline, or at any point during the week at issue, he is not eligible for benefits for week 28-25.

DECISION: Order No. 25-UI-306822 is affirmed.
