EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0638

Affirmed No Disqualification

PROCEDURAL HISTORY: On July 28, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits beginning June 8, 2025 (decision # L0012031199). Claimant filed a timely request for hearing. On September 23, 2025, ALJ Hall conducted a hearing, and on October 1, 2025 issued Order No. 25-UI-305480, reversing decision # L0012031199 by concluding that claimant's discharge was not for misconduct and did not disqualify her from receiving benefits. On October 21, 2025, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered the employer's written argument when making this decision. The employer argued that claimant was discharged due to her failure to exercise reasonable care and attention while performing assigned duties, which constituted negligence. Employer's Written Argument at 1. However, while claimant's conduct may have been negligent, the employer did not meet their burden to show that it was *wantonly* negligent, as required by ORS 657.176(2)(a) and defined under OAR 471-030-0038.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-305480's findings of fact, reasoning, and conclusion that claimant's discharge was not for misconduct and did not disqualify her from receiving benefits. Order No. 25-UI-305480 is **adopted**. *See* ORS 657.275(2).

DECISION: Order No. 25-UI-305480 is affirmed.

¹ Decision # L0012031199stated that claimant was denied benefits from June 8, 2025 to June 6, 2026. However, decision # L0012031199 should have stated that claimant was disqualified from receiving benefits beginning June 8, 2025 and until she earned four times her weekly benefit amount. *See* ORS 657.176.
