

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0647

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 5, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning April 20, 2025 because she was discharged by the employer for misconduct (decision # L0011073970).¹ On June 25, 2025, decision # L0011073970 became final without claimant having filed a request for hearing. On July 28, 2025 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 8, 2025 issued Order No. 25-UI-300194, dismissing the request as late, subject to claimant's right to renew her request by responding to an appellant questionnaire by August 22, 2025. On August 15, 2025, claimant renewed her late request for hearing by filing a timely response to appellant questionnaire.

On September 29, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for October 7, 2025 on whether to allow claimant's late request for hearing and, if so, the merits of decision # L0011073970. On October 7, 2025, ALJ Contreras conducted the hearing and issued Order No. 25-UI-306282, re-dismissing claimant's late request for hearing as without good cause and leaving decision # L0011073970 undisturbed. On October 27, 2025, claimant filed a timely application for review of Order No. 25-UI-306282 with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-306282's findings of fact, reasoning, and denial of claimant's late request for hearing on decision # L0011073970. Order No. 25-UI-306282 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-306282 is affirmed.

¹ Decision # L0011073970 stated that claimant was denied benefits from April 20, 2025 to April 18, 2026. However, decision # 0011073970 should have stated that claimant was disqualified from receiving benefits beginning April 20, 2025 and until she earned four times her weekly benefit amount. See ORS 657.176.
