EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0655

Affirmed No Disqualification

PROCEDURAL HISTORY: On August 13, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant therefore was disqualified from receiving unemployment insurance benefits effective May 25, 2025 (decision # L0012378910). Claimant filed a timely request for hearing. On October 10, 2025, ALJ Messecar conducted a hearing, and on October 17, 2025 issued Order No. 25-UI-307598, reversing decision # L0012378910 by concluding that the employer discharged claimant, but not for misconduct, and claimant therefore is not disqualified from receiving benefits based on the work separation. On November 3, 2025, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer submitted a written argument on November 3, 2025. The employer did not state that they provided a copy of their argument to claimant as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only the information received into evidence at the hearing. *See* ORS 657.275(2).

Claimant submitted a written argument on November 7, 2025. EAB did not consider claimant's written argument because she did not state that she provided a copy of her argument to the employer as required by OAR 471-041-0080(2)(a).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-307598's findings of fact, reasoning, and conclusion that the employer discharged claimant, but not for misconduct, and

claimant therefore is not disqualified from receiving unemployment insurance benefits based on the work separation. Order No. 25-UI-307598 is **adopted**. *See* ORS 657.275(2).

DECISION: Order No. 25-UI-307598 is affirmed.
