# EMPLOYMENT APPEALS BOARD DECISION 2025-EAB-0657

Late Application for Review Dismissed Without Prejudice

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On September 3, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide identity verification information in accordance with the Department's rules and was ineligible for benefits for the week of August 24 through 30, 2025 (week 35-25), and until the reason for the denial ended (decision # L0012713586). On September 23, 2025, decision # L0012713586 became final without claimant having filed a request for hearing.

On September 27, 2025, claimant filed a late request for hearing on decision # L0012713586. ALJ Kangas considered claimant's request, and on October 8, 2025 issued Order No. 25-UI-306326, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 22, 2025. On October 28, 2025, Order No. 25-UI-306326 became final without claimant having filed a response to the appellant questionnaire, or an application for review with the Employment Appeals Board (EAB). On October 30, 2025, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 25-UI-306326 with the EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's written statement submitted with their application for review. The written statement is marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must send the objection to EAB in writing, stating why they object, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** Claimant's application for review is dismissed without prejudice.

On October 30, 2025, claimant filed an application for review of Order No. 25-UI-306326 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than October 28, 2025. Claimant's application for review is therefore late, and the application for review is dismissed.

However, the deadline for filing an application for review may be extended a reasonable time if the applicant can show they have good cause to extend the deadline. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If claimant believes they have good cause and filed their late application for review within a reasonable time, claimant may ask EAB to *reconsider* this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all four of the following:

- 1. Claimant must file the request for reconsideration by December 11, 2025, and
- 2. Claimant must provide more specific details about the reason they filed a *late* application for review. For example, claimant should include specific information about the date they received the ALJ's Order No. 25-UI-306326, whether they read and disagreed with it, and how they were prevented from filing their application for review by October 28, 2025. Claimant should include specific details that might help EAB decide whether claimant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
- 3. Claimant must provide the date the circumstances that prevented them from filing a timely application for review ended (the circumstances they listed in response to #3, above), *and*
- 4. Claimant must provide sufficient information to prove that they filed their application for review within **seven** days of the date the circumstances that prevented them from filing a timely application for review ended.

There are several ways to file a request for reconsideration:

Please note that you need only file *one* request for reconsideration.

**DECISION:** The application for review filed October 30, 2025 is dismissed without prejudice. Order No. 25-UI-306326 remains undisturbed.
