

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0675

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 3, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant failed to register for work and was not eligible for benefits beginning the week of May 18, 2025 and until claimant registered for work (decision # L0011083748). On June 23, 2025, decision # L0011083748 became final without claimant having filed a request for hearing.

On September 5, 2025, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 17, 2025 issued Order No. 25-UI-307557, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 31, 2025. On November 6, 2025, Order No. 25-UI-307557 became final without claimant having filed a response to the appellant questionnaire, or application for review of Order No. 25-UI-307557 with the Employment Appeals Board (EAB). On November 10, 2025, claimant filed a late application for review of Order No. 25-UI-307557 with EAB.

FINDING OF FACT: (1) Order No. 25-UI-307557, mailed to claimant on October 17, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-307557 at 2. Order No. 25-UI-307557 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 6, 2025."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-307557 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-307557 was due November 6, 2025. Because claimant did not file their application for review until November 10, 2025, the application for review was late. Claimant’s application for review did not include a written statement describing circumstances preventing them from filing the application for review by the November 6, 2025 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed November 10, 2025 is dismissed. Order No. 25-UI-307557 remains undisturbed.
