

**EMPLOYMENT APPEALS BOARD DECISION**  
**2025-EAB-0690**

*Affirmed*  
*Ineligible May 25 to June 21, 2025*  
*(Weeks 22-25 to 25-25)*

**PROCEDURAL HISTORY:** On August 13, 2025, the Oregon Employment Department (the Department) served notice of two administrative decisions concluding that claimant did not actively seek work during the weeks of May 25 to May 31, 2025 and June 8 to June 14, 2025 (weeks 22-25 and 24-25) and was ineligible for benefits for those weeks (decision #s L0012279023 and L0012402186, respectively). On August 18, 2025, the Department served notice of two administrative decisions concluding that claimant did not actively seek work during the weeks of June 1 to June 7, 2025 and June 15 to June 21, 2025 (weeks 23-25 and 25-25) and was ineligible for benefits during those weeks (decision #s L0012587290 and L0012571052, respectively).

Claimant filed timely requests for hearing on the decisions. On October 20, 2025, ALJ Frank conducted a hearing, and on October 23, 2025 issued Order Nos. 25-UI-308211, 25-UI-308213, 25-UI-308210, and 25-UI-308214, affirming decisions # L0012279023, L0012402186, L0012587290, and L0012571052, respectively. On November 12, 2025, claimant filed applications for review with the Employment Appeals Board (EAB).

**ORDER CONSOLIDATION:** EAB combined its review of Orders No. 25-UI-308211, 25-UI-308213, 25-UI-308210, and 25-UI-308214 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2025-EAB-0690, 2025-EAB-0699, 2025-EAB-0682, and 2025-EAB-0701).

**ADOPTION OF HEARING ORDERS:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order Nos. 25-UI-308211, 25-UI-308213, 25-UI-308210, and 25-UI-308214's findings of fact, reasoning, and conclusion that claimant worked during the weeks of May 25 through June 21, 2025, earned remuneration exceeding her weekly benefit amount, and therefore was not unemployed and was not eligible for benefits for those weeks. Order Nos. 25-UI-308211, 25-UI-308213, 25-UI-308210, and 25-UI-308214 are **adopted**. See ORS 657.275(2).

**DECISION:** Order Nos. 25-UI-308211, 25-UI-308213, 25-UI-308210, and 25-UI-308214 are affirmed.
