

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0713

Affirmed
Request for Hearing Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY: On July 21, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer with good cause and was not disqualified from receiving benefits based on the quit (decision # L0022964922).¹ On August 11, 2025, decision # L0022964922 became final without the employer or claimant having filed a request for hearing. On September 18, 2025, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 30, 2025 issued Order No. 25-UI-308970, dismissing the request as presenting no justiciable controversy because decision # L0022964922 was in claimant's favor. On November 12, 2025, the employer filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record. EAB agrees with Order No. 25-UI-308970's findings of fact, reasoning, and dismissal of claimant's request for hearing as presenting no justiciable controversy. Order No. 25-UI-308970 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-308970 is affirmed.
