

EMPLOYMENT APPEALS BOARD DECISION
2025-EAB-0802

Affirmed
Not Eligible Weeks 33-25 through 36-25

PROCEDURAL HISTORY: On August 19, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to confirm their identity as required by the Oregon Employment Department and was therefore not eligible for unemployment insurance benefits beginning August 10, 2025 and until claimant provided the requested information (decision # L0012589104). Claimant filed a timely request for hearing. On December 8, 2025, ALJ Blam conducted a hearing, and on December 16, 2025 issued Order No. 25-UI-314394, modifying decision # L0012589104 by concluding that claimant failed to confirm their identity information and was not eligible for benefits for the weeks of August 10 through September 6, 2025. On December 19, 2025, claimant filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-314394's findings of fact, reasoning, and conclusion that claimant failed to confirm their identity information as required by the Department and therefore was not eligible for benefits for the weeks of August 10 through September 6, 2025 (weeks 33-25 through 36-25). Order No. 25-UI-314394 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-314394 is affirmed.
