

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0007**

*Reversed*  
*Late Request for Hearing Allowed*  
*Merits Hearing Required*

**PROCEDURAL HISTORY:** On October 21, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide identity verification information and was therefore ineligible to receive unemployment insurance benefits effective October 12, 2025, and until the reason for the denial ended (decision # L0013669178). On November 10, 2025, decision # L0013669178 became final without claimant having filed a request for hearing. On November 20, 2025, claimant filed a late request for hearing. ALJ Kangas considered the request, and on December 16, 2025 issued Order No. 25-UI-314389, dismissing the request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 30, 2025. On December 24, 2025, claimant filed an appellant questionnaire response and an application for review with the Employment Appeals Board (EAB).

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's appellant questionnaire response, has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) Decision # L0013669178, mailed to claimant's address on file with the Department on October 21, 2025, stated, "You have the right to appeal our decision and request a hearing if you believe our decision is wrong. We must receive your request for a hearing no later than **November 10, 2025.**" Exhibit 1 at 2 (emphasis in original).

(2) On November 16, 2025, claimant received decision # L0013669178. Claimant was previously unaware that the decision had been issued.

(3) On November 20, 2025, claimant filed a late request for hearing on decision # L0013669178.

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing is allowed, and the matter remanded for a hearing on the merits of decision # L0013669178.

ORS 657.269 states that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 states that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) states that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ended.

The request for hearing on decision # L0013669178 was due by November 10, 2025. Claimant's request for hearing was filed on November 20, 2025, and was therefore late. Claimant wrote in the appellant questionnaire response that they received decision # L0013669178 on November 16, 2025. EAB Exhibit 1 at 1. While claimant did not elaborate on the possible reasons for the late delivery of decision # L0013669178, it is reasonable to infer that receiving the administrative decision after the November 10, 2025 appeal deadline was a factor beyond claimant's reasonable control that prevented timely filing of a request for hearing. Good cause has therefore been shown to extend the filing deadline.

Moreover, claimant filed the late request for hearing on November 20, 2025, four days after the factor that prevented timely filing ended with claimant's receipt of decision # L0013669178 on November 16, 2025. As such, the late request for hearing was filed within a "reasonable time." Accordingly, claimant's late request for hearing is allowed, and a hearing on the merits of decision # L0013669178 is required.

**DECISION:** Order No. 25-UI-314389 is set aside. Claimant's late request for hearing is allowed, and this matter remanded for further proceedings consistent with this order.
