

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0023

Affirmed
Claim Not Monetarily Valid

PROCEDURAL HISTORY: On October 30, 2025, the Oregon Employment Department (the Department) served notice of a wage and potential benefit report (WPBR) concluding that claimant had insufficient wages and hours worked during the base year to establish a monetarily valid claim for unemployment insurance benefits (decision # L0013822360). Claimant filed a timely request for hearing. On December 24, 2025, ALJ Griffith conducted a hearing, and on December 29, 2025 issued Order No. 25-UI-315566, affirming decision # L0013822360. On January 2, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument in reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-315566's findings of fact, reasoning, and conclusion that wages reported on the WPBR were correctly assigned to the calendar quarters in which they were paid, pursuant to OAR 471-030-0010 (January 11, 2018), and the resulting base year wages and hours worked were insufficient to establish a monetarily valid claim for benefits. Order No. 25-UI-315566 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-315566 is affirmed.
