

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0037

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On November 10, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause, and therefore was disqualified from receiving unemployment insurance benefits effective September 28, 2025 (decision # L0014022532).¹ On December 1, 2025, decision # L0014022532 became final without the Department having received a request for hearing from claimant. On December 5, 2025, claimant filed a late request for hearing on decision # L0014022532.

ALJ Kangas considered claimant's request, and on December 18, 2025 issued Order No. 25-UI-314731, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 1, 2026. On January 6, 2026, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 25-UI-314731 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

¹ Decision # L0014022532 stated that claimant was denied benefits from October 12, 2025 to October 10, 2026. However, as decision # L0014022532 found that claimant quit work on October 2, 2025, it should have stated that claimant was disqualified from receiving benefits beginning Sunday, September 28, 2025 and until they earned four times their weekly benefit amount. *See* ORS 657.176.

CONCLUSIONS AND REASONS: Order No. 25-UI-314731 is set aside and this matter remanded for a hearing on whether claimant’s late request for hearing on decision # L0014022532 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department’s decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a “reasonable time” upon a showing of “good cause.” OAR 471-040-0010 (February 10, 2012) provides that “good cause” includes factors beyond an applicant’s reasonable control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

The request for hearing on decision # L0014022532 was due by December 1, 2025. Because claimant did not file their request for hearing until December 5, 2025, the request was late.

On their response to the appellant questionnaire, claimant indicated that they received decision # L0014022532 on November 24, 2025, and that they filed their request for hearing on December 1, 2025 by talking to a representative on the phone and via a Frances Online message. EAB Exhibit 1 at 1. Claimant further asserted that, although they had timely filed their request for hearing, they believed that “because of the holiday week it was not put in, in the appropriate time.” EAB Exhibit 1 at 2. In addition to claimant’s statements, a comment in claimant’s claim in Frances Online, dated December 16, 2025, states, “WEB NOTICE 12/03/25 Confirmed appeal request re Work Sep Decision sent to [the Office of Administrative Hearings], provided general info re appeals process and advised to continue filing.”²

Taken together, the above suggests that claimant may have filed, or attempted to file, a request for hearing earlier than December 5, 2025. On remand, the ALJ should inquire as to what steps claimant took, and on what date, to file or attempt to file a timely request for hearing on decision # L0014022532. Additionally, the Department should produce a witness who can offer testimony on the December 16, 2025 comment to further explain what it referred to regarding what appeared to be a request that claimant made on or prior to December 3, 2025.

To the extent that the record on remand shows that claimant more likely than not filed a timely request for hearing, the ALJ should proceed to the merits of decision # L0014022532. Otherwise, the ALJ should inquire as to what circumstances, if any, prevented claimant from filing a timely request for hearing, when those circumstances ended, and whether claimant filed a late request for hearing within a reasonable time.

Order No. 25-UI-314731 therefore is reversed, and this matter remanded for a hearing on whether claimant filed a timely request for hearing or, in the alternative, whether claimant’s late request for hearing should be allowed; and, if so, the merits of decision # L0014022532.

² EAB has taken notice of these facts, which are contained in Employment Department records. OAR 471-041-0090(1). Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the noticed facts will remain in the record.

DECISION: Order No. 25-UI-314731 is set aside, and this matter remanded for further proceedings consistent with this order.
