

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0039

Affirmed
Request to Reopen Allowed
Not Eligible for Benefits Week 26-25

PROCEDURAL HISTORY: On July 1, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to confirm his identity as required by the Department and therefore was denied unemployment insurance benefits beginning June 22, 2025 (decision # L0011632439). Claimant filed a timely request for hearing. On August 20, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 12, 2025. On September 12, 2025, claimant failed to appear at the hearing, and ALJ Triana issued Order No. 25-UI-303732, dismissing claimant's request for hearing due to his failure to appear. On September 25, 2025, claimant filed a timely request to reopen the hearing.

On January 2, 2026, ALJ Blam conducted a hearing. The Department provided a written statement called an Attestation instead of having a witness attend the hearing. Also on January 2, 2026, ALJ Blam issued Order No. 26-UI-315910, concluding that good cause for reopening the hearing had been shown, cancelling Order No. 25-UI-303732 and affirming decision # L0011632439 by concluding that claimant failed to confirm his identity as required by the Department and was not eligible for benefits the week of June 22 through June 28, 2025 (week 26-25). On January 8, 2026, claimant filed an application for review of Order No. 26-UI-315910 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony, the Department's Attestation, and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-315910's findings of fact, reasoning, and conclusion that good cause for reopening the hearing was shown, cancelling Order No. 25-UI-303732, and that claimant failed to confirm his identity as required by the Department and was not eligible for benefits the week of June 22 through 28, 2025 (week 26-25). Order No. 26-UI-315910 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-315910 is affirmed.
