

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0047**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On September 11, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and therefore was disqualified from receiving unemployment insurance benefits beginning July 13, 2025 (decision # L0012980823).<sup>1</sup> Claimant filed a timely request for hearing. On September 24, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for October 7, 2025. On October 7, 2025, claimant failed to appear at the hearing, and ALJ Murdock issued Order No. 25-UI-306190, dismissing claimant's request for hearing due to his failure to appear. On October 16, 2025, claimant filed a timely request to reopen the hearing.

On December 16, 2025, ALJ Bender conducted a hearing and on December 24, 2025, issued Order No. 25-UI-315392, concluding that good cause for reopening the hearing had been shown, cancelling Order No. 25-UI-306190, and reversing decision # L0012980823 by concluding that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. On January 9, 2026, the employer filed an application for review of Order No. 25-UI-306190 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** The employer's argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-315392's findings of fact, reasoning, and conclusion that good cause for reopening the hearing was shown, cancelling

<sup>1</sup> Decision # L0012980823 stated that claimant was denied benefits from July 13, 2025 to August 8, 2026. However, decision # L0012980823 should have said that claimant was disqualified from receiving benefits beginning Sunday, July 13, 2025 and until he earned four times his weekly benefit amount. *See* ORS 657.176.

Order No. 25-UI-306190, and that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. Order No. 25-UI-315392 is **adopted**. *See* ORS 657.275(2).

**DECISION:** Order No. 25-UI-315392 is affirmed.
