

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0074

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 15, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to confirm their identity as required by the Department and was denied benefits beginning April 6, 2025 (decision # L0010288542). On May 5, 2025, decision # L0010288542 became final without claimant having filed a request for hearing. On December 15, 2025, claimant filed a late request for hearing on decision # L0010288542.

ALJ Kangas considered claimant's request, and on December 17, 2025 issued Order No. 25-UI-314688, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 31, 2025. On January 6, 2026, Order No. 25-UI-314688 became final without claimant having filed an appellant questionnaire response or application for review with the Employment Appeals Board (EAB).

On January 20, 2026, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 25-UI-314688 with the Employment Appeals Board (EAB). On February 4, 2026, ALJ Kangas issued a Final Order of Dismissal, Order No. 26-UI-319181, because claimant's response to the appellant questionnaire was not timely.¹ This matter comes before EAB based upon claimant's January 20, 2026 late application for review of Order No. 25-UI-314688.

FINDING OF FACT: (1) Order No. 25-UI-314688 mailed to claimant on December 17, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-314688 at 2. Order No. 25-UI-314688 also said on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than January 6, 2026."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 25-UI-314688 is dismissed.

An application for review to the Employment Appeals Board (EAB) is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-314688 to EAB was due by January 6, 2026. Because claimant did not file their application for review until January 20, 2026, the application for review was late. Although claimant filed a late appellant questionnaire response to explain why they filed a late request for hearing on decision # L0010288542, claimant’s application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the January 6, 2026 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed January 20, 2026 is dismissed. Order No. 25-UI-314688 remains undisturbed.
