

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0097

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 20, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able, available, or actively seeking work and therefore was ineligible for unemployment insurance benefits effective October 3, 2021 and until the reason for the denial ended (decision # 144216). On November 9, 2021, decision # 144216 became final without claimant having filed a request for hearing. On December 1, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 22, 2022, issued Order No. 22-UI-186941, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 8, 2022. On or about March 1, 2022, claimant filed a timely response to the appellant questionnaire.

On May 12, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-186941 was vacated and that a hearing would be scheduled to determine whether claimant's late request for hearing should be allowed, and if so, the merits of decision # 144216. On July 7, 2022, ALJ Frank conducted a hearing at which the employer did not appear, and on July 14, 2022 issued Order No. 22-UI-198270, re-dismissing claimant's request for hearing as late without good cause and leaving decision # 144216 undisturbed. On August 3, 2022, Order No. 22-UI-198270 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 30, 2026, claimant filed a late application for review of Order No. 22-UI-198270 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant submitted with her application for review, which has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-198270, mailed to claimant on July 14, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment

Appeals Board within 20 days of the date that this decision is mailed.” Order No. 22-UI-198270 at 3. Order No. 22-UI-198270 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before August 3, 2022 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 22-UI-198270 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-198270 was due August 3, 2022. Because claimant did not file her application for review until January 30, 2026, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe the circumstances that prevented her from filing the application for review on time. *See* EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed January 30, 2026 is dismissed. Order No. 22-UI-198270 remains undisturbed.
