

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0104**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On July 15, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was suspended from work for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective June 1, 2025 (decision # L0011788575).<sup>1</sup> Claimant filed a timely request for hearing. On September 8, 2025, notice was mailed to the parties that a hearing was scheduled for September 23, 2025. On September 23, 2025, ALJ Scott conducted a hearing at which the employer failed to appear, and issued Order No. 25-UI-304680, reversing decision # L0011788575 by concluding that claimant was suspended from work, but not for misconduct, and therefore was not disqualified from receiving benefits based on the suspension from work. On October 6, 2025, the employer filed an application for review of Order No. 25-UI-304680 that was treated as a request to reopen the September 23, 2025 hearing.<sup>2</sup> ALJ Kangas considered the request, and on January 26, 2026 issued Order No. 26-UI-318024, denying the employer's request to reopen the September 23, 2025 hearing.<sup>3</sup> Under OAR 471-040-0040(6), the employer's October 6, 2025 application for review was forwarded to the Employment Appeals Board (EAB) for a review of the merits of Order No. 25-UI-304680. This matter comes before EAB based upon the employer's October 6, 2025 application for review of Order No. 25-UI-304680.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-304680's findings of fact, reasoning, and conclusion that claimant was suspended from work, but not for misconduct, and is not disqualified from receiving benefits based on the suspension from work. Order No. 25-UI-304680 is **adopted**. See ORS 657.275(2).

However, decision # L0011788575 should have stated that claimant was disqualified from receiving benefits beginning Sunday, June 1, 2025, and until he earned four times his weekly benefit amount.
