

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0105

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 27, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed a late claim for benefits for the week of October 5 through October 11, 2025 (week 41-25), and was ineligible for benefits for that week (decision # L0013852816). Claimant filed a timely request for hearing. On December 22, 2025, ALJ Goodrich conducted a hearing, and on December 24, 2025, issued Order No. 25-UI-315380, reversing decision # L0013852816 by concluding that claimant was eligible to receive benefits for week 41-25. On January 13, 2026, Order No. 25-UI-315380 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 17, 2026, claimant filed a late application for review of Order No. 25-UI-315380 with EAB.

FINDINGS OF FACT: (1) Order No. 25-UI-315380, mailed to claimant on December 24, 2025, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 25-UI-315380 at 4. Order No. 25-UI-315380 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before January 13, 2026 to be timely.”

(2) On January 13, 2026, Order No. 25-UI-315380 became final without claimant having filed an application for review with EAB. On January 17, 2026, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 25-UI-315380 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing

ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-315380 was due by January 13, 2026. Because claimant did not file her application for review until January 17, 2026, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented her from filing the application for review by the January 13, 2026 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.¹

DECISION: The late application for review filed January 17, 2026 is dismissed. Order No. 25-UI-315380 remains undisturbed.

¹ Claimant should note that she was the prevailing party in Order No. 25-UI-315380 as the result of the order was to reverse decision # L0013852816 and conclude that she was eligible to receive benefits for week 41-25. The late application for review of Order No. 25-UI-315380 therefore presents no justiciable controversy and would be subject to dismissal for that reason in addition to the fact that it was filed late.
