

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0108**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On December 15, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective November 9, 2025 (decision # L0014717364).<sup>1</sup> Claimant filed a timely request for hearing. On January 27, 2026, ALJ Hall conducted a hearing, and on January 30, 2026 issued Order No. 26-UI-318708, affirming decision # L0014717364. On February 2, 2026, claimant filed an application for review of Order No. 26-UI-318708 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-318708's findings of fact, reasoning, and conclusion that claimant quit work without good cause and was disqualified from

receiving benefits based on the work separation, effective November 9, 2025. Order No. 26-UI-318708 is **adopted**. *See* ORS 657.275(2).

**DECISION:** Order No. 26-UI-318708 is affirmed.
