

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0114**

*Late Application for Review Allowed*  
*Affirmed*  
*Request to Backdate Denied*

**PROCEDURAL HISTORY:** On October 8, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant’s request to backdate his initial claim (decision # L0013254399).<sup>1</sup> Claimant filed a timely request for hearing. On December 26, 2025, ALJ Honea conducted a hearing, and on January 2, 2026 issued Order No. 26-UI-315985, affirming decision # L0013254399. On January 22, 2026, Order No. 26-UI-315985 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On or about February 4, 2026, claimant filed a late application for review of Order No. 26-UI-315985 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant’s written statement, which was included with his application for review, has been marked as EAB Exhibit 1, and provided to the parties with this decision. Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, saying why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 26-UI-315985, mailed to claimant on January 2, 2026, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 26-UI-315985 at 3. Order No. 26-UI-315985 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before January 22, 2026 to be timely.”

<sup>1</sup> Decision # L0013254399 denied claimant’s request to backdate his initial claim to September 14, 2025. Claimant testified he was requesting to backdate his initial claim to September 21, 2025.

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 26-UI-315985 is allowed. Order No. 26-UI-315985 is affirmed on the merits.

**Late Application for Review.** An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-315985 was due January 22, 2026. Because claimant did not file his application for review until February 4, 2026, the application for review was late. Claimant provided a written statement with the application for review which described the circumstances that prevented timely filing. Claimant explained in the statement that he has “a documented disability of OCD and depression.” EAB Exhibit 1. He further explained that he is “living in unhealthy conditions,” suffered a nervous breakdown previously, and is “experiencing the same again.” EAB Exhibit 1. Claimant further stated that he has been attending an outpatient program, is meeting weekly with a therapist, and while he has “struggled” throughout the years, his ability to cope has been impacted by recent life events. EAB Exhibit 1. It can reasonably be concluded from these statements that claimant’s deteriorating mental health constituted a circumstance beyond claimant’s reasonable control that prevented timely filing. Moreover, that circumstance has been on-going and it can be inferred the circumstance continued up through at least the date claimant filed his late application for review. Claimant therefore had good cause to extend the filing period and filed within a reasonable time. Claimant’s late application for review of Order 26-UI-315985 is allowed.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-315985’s findings of fact, reasoning, and conclusion denying claimant’s request to backdate his initial claim. Order No. 26-UI-315985 is **adopted**. *See* ORS 657.275(2).

**DECISION:** Claimant’s late application for review of Order 26-UI-315985 is allowed. Order No. 26-UI-315985 is affirmed.
