

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0125**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On August 14, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant was disqualified from receiving benefits effective June 22, 2025 (decision # L0012415562).<sup>1</sup> Claimant filed a timely request for hearing. On September 29, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for October 10, 2025. On October 10, 2025, claimant failed to appear at the hearing, and ALJ Christon issued Order No. 25-UI-306870, dismissing claimant's request for hearing due to their failure to appear. On October 20, 2025, claimant filed a timely request to reopen the October 10, 2025 hearing. On January 7, 2026, ALJ Contreras conducted a hearing at which the employer did not appear, and on January 20, 2026 issued Order No. 26-UI-317460, denying claimant's request to reopen and leaving Order No. 25-UI-306870 undisturbed. On February 6, 2026, claimant filed an application for review of Order No. 26-UI-317460 with the Employment Appeals Board (EAB).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-317460's findings of fact, reasoning, and conclusion that claimant's request to reopen was without good cause and leaving Order No. 25-UI-306870, dismissing claimant's request for hearing due to their failure to appear, undisturbed. Order No. 26-UI-317460 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-317460 is affirmed.
