

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0129**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On October 6, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause, and therefore was disqualified from receiving unemployment insurance benefits effective August 31, 2025 through August 29, 2026 (decision # L0013283473). Claimant filed a timely request for hearing. On January 15, 2026, ALJ Micheletti conducted a hearing, and on January 23, 2026, issued Order No. 26-UI-317899, modifying decision # L0013283473 by concluding that claimant voluntarily quit work without good cause, and therefore was disqualified from receiving benefits effective August 24, 2025 and until requalified under Department law. On February 8, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant filed written arguments on February 8, 2026 and March 3, 2026. EAB did not consider claimant's February 8, 2026 written argument because she did not state that she provided a copy of her argument to the employer as required by OAR 471-041-0080(2)(a) (May 13, 2019). Additionally, both arguments contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing. EAB considered any parts of claimant's March 3, 2026 argument that were based on the hearing record.

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-317899's findings of fact, reasoning, and conclusion that claimant voluntarily quit work without good cause.<sup>1</sup> Order No. 26-UI-317899 is **adopted**. See ORS 657.275(2).

<sup>1</sup> The order under review contained several scrivener's errors regarding dates relevant to this matter, including findings that claimant worked for the employer through May 28, 2025 rather than August 28, 2025; that claimant's supervisor informed claimant that she would be placing claimant on a performance improvement plan in "Aug[u]st 20025," rather than June 2025; and that claimant "quit her job on August 28, 20256," rather than August 28, 2025. Order No. 26-UI-317899 at 1-2.

**DECISION:** Order No. 26-UI-317899 is affirmed.

Nevertheless, because the correct dates can be discerned from context, and because the order under review correctly concluded that claimant should be disqualified from receiving benefits effective August 24, 2025 (based on her having quit on August 28, 2025), these errors are not material to the outcome in this matter.
