

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0142**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On December 3, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant therefore was disqualified from receiving unemployment insurance benefits effective October 26, 2025 (decision # L0014376478).<sup>1</sup> Claimant filed a timely request for hearing. On February 2, 2026, ALJ Hall conducted a hearing, and on February 10, 2026, issued Order No. 26-UI-319796, reversing decision # L0014376478 by concluding that the employer discharged claimant, but not for misconduct, and claimant therefore was not disqualified from receiving benefits based on the work separation. On February 12, 2026, the employer filed an application for review with the Employment Appeals Board (EAB).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-319796's findings of fact, reasoning, and conclusion that the employer discharged claimant, but not for misconduct, and claimant therefore was not disqualified from receiving benefits based on the work separation. Order No. 26-UI-319796 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-319796 is affirmed.

However, decision # L0014376478 should have stated that claimant was disqualified from receiving benefits beginning Sunday, October 26, 2025 and until he earned four times his weekly benefit amount. See ORS 657.176.
