

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0143

Affirmed
Disqualification

PROCEDURAL HISTORY: On October 6, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant therefore was denied unemployment insurance benefits from August 24, 2025 to August 29, 2026 (decision # L0013253684). Claimant filed a timely request for hearing. On January 20, 2026, ALJ Krueger conducted a hearing, and on January 23, 2026 issued Order No. 26-UI-317841, modifying decision # L0013253684 by concluding that claimant was discharged for misconduct and therefore was disqualified from receiving benefits effective August 24, 2025. On February 12, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-317841's findings of fact, reasoning, and conclusion that claimant was discharged for misconduct and therefore was disqualified from receiving benefits effective August 24, 2025. Order No. 26-UI-317841 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-317841 is affirmed.
