

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0144

Late Application for Review Dismissed

PROCEDURAL HISTORY: On October 10, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective August 24, 2025 (decision # L0013282039).¹ Claimant filed a timely request for hearing. On January 15, 2026, ALJ Griffith conducted a hearing, and on January 21, 2026, issued Order No. 26-UI-317492, affirming decision # L0013282039. On February 10, 2026, Order No. 26-UI-317492 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 12, 2026, claimant filed a late application for review of Order No. 26-UI-317492 with EAB.

FINDING OF FACT: (1) Order No. 26-UI-317492, mailed to claimant on January 21, 2026, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 26-UI-317492 at 3. Order No. 26-UI-317492 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before February 10, 2026 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 26-UI-317492 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing

ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-317492 was due by February 10, 2026. Because claimant did not file his application for review until February 12, 2026, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented him from filing the application for review by the February 10, 2026 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed February 12, 2026 is dismissed. Order No. 26-UI-317492 remains undisturbed.
