

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0145**

*Affirmed*  
*Late Request to Reopen Denied*

**PROCEDURAL HISTORY:** On September 12, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective July 27, 2025 (decision # L0012972992).<sup>1</sup> Claimant filed a timely request for hearing. On October 30, 2025, notice was mailed to the parties that a hearing was scheduled for November 12, 2025. On November 12, 2025, claimant failed to appear for the hearing, and ALJ Krueger issued Order No. 25-UI-310239, dismissing claimant's request for hearing due to the failure to appear. On December 2, 2025, Order No. 25-UI-310239 became final without claimant having filed a request to reopen the hearing. On December 8, 2025, claimant filed a late request to reopen the November 12, 2025 hearing. ALJ Kangas considered the request, and on February 5, 2026 issued Order No. 26-UI-319364, denying the late request to reopen and leaving Order No. 25-UI-310239 undisturbed. On February 12, 2026, claimant filed an application for review of Order No. 26-UI-319364 with the Employment Appeals Board (EAB).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-319364's findings of fact, reasoning, and conclusion that claimant's late request to reopen the November 12, 2025 hearing should be denied. Order No. 26-UI-319364 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-319364 is affirmed.

<sup>1</sup> Decision # L0012972992 stated that claimant was denied benefits from August 3, 2025 to August 1, 2026. However, as decision # L0012972992 concluded that the work separation occurred on July 31, 2025, it should have stated that claimant was disqualified from receiving benefits beginning Sunday, July 27, 2025, and until they earned four times their weekly benefit amount. See ORS 657.176.
