

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0154

Dismissed
Application for Review Withdrawn

PROCEDURAL HISTORY: On December 9, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to confirm their identity as required by the Department and therefore was ineligible to receive unemployment insurance benefits effective November 30, 2025 and until the reason for the denial ended (decision # L0014621957). Claimant filed a timely request for hearing. On January 23, 2026, ALJ Micheletti conducted a hearing, and on January 26, 2026 issued Order No. 26-UI-318081, modifying decision # L0014621957 by concluding that claimant was not eligible to receive benefits for the period of November 30, 2025 to January 3, 2026.¹ On February 16, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

FINDING OF FACT: (1) On March 12, 2026, the claimant submitted a written request to withdraw their application for review of Order No. 26-UI-318081.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

OAR 471-041-0098 (October 29, 2006) provides that an applicant's written request to withdraw an application for review will be allowed unless the request is received after EAB's decision has been issued.

On March 12, 2026, EAB received an email from claimant in which claimant withdrew the application for review of Order No. 26-UI-318081. EAB had not yet issued a decision. Under OAR 471-041-0098, the claimant's request to withdraw is allowed.

¹ Although Order No. 26-UI-318081 stated it affirmed decision # # L0014621957 it modified that decision by changing the on-going date of the disqualification to an ending disqualification date of January 3, 2026. Order No. 26-UI-318081 at 4.

DECISION: The application for review filed February 16, 2026 is dismissed. Order No. 26-UI-318081 remains undisturbed.
