

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0156

Affirmed
Eligible Weeks 51-25 and 53-25
Not Eligible Weeks 52-25 and 01-26

PROCEDURAL HISTORY: On January 5, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work and therefore was ineligible to receive unemployment insurance benefits during the weeks of December 14, 2025 through January 10, 2026 (weeks 51-25 through 01-26) (decision # L0014942967). Claimant filed a timely request for hearing. On February 3, 2026, ALJ Parnell conducted a hearing. The Department provided a written statement called an Attestation instead of having a witness attend the hearing. On February 5, 2026, ALJ Parnell issued Order No. 26-UI-319387, modifying decision # L0014942967 by concluding that claimant was available for work and therefore eligible to receive benefits for the weeks of December 14 through December 20, 2025 (week 51-25), and December 28, 2025 through January 3, 2026 (week 53-25), but was not available for work and therefore was ineligible to receive benefits for the weeks of December 21 through December 27, 2025 (week 52-25), and January 4 through January 10, 2026 (week 01-26). On February 17, 2026, claimant filed an application for review of Order No. 26-UI-319387 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's argument in reaching this decision.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-319387's findings of fact, reasoning, and conclusion that claimant was available for work and therefore eligible to receive benefits for week 51-25 and week 53-25, but was not available for work and therefore was ineligible to receive benefits for week 52-25 and week 01-26. Order No. 26-UI-319387 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-319387 is affirmed.
