

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0164

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 14, 2024, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # L0007249150). The employer filed a timely request for hearing. On January 2, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 16, 2025. On January 16, 2025, ALJ Janzen conducted a hearing at which claimant did not appear, and on January 17, 2025 issued Order No. 25-UI-280258, reversing decision # L0007249150 by concluding that the employer discharged claimant for misconduct and claimant was disqualified from receiving benefits effective September 29, 2024 based on the work separation. On February 6, 2025, Order No. 25-UI-280258 became final without claimant having filed a request to reopen the hearing with OAH or an application for review with the Employment Appeals Board (EAB).

On February 11, 2025, claimant filed a late application for review of Order No. 25-UI-280258 with EAB. The application for review was treated as a late request to reopen under OAR 471-041-0060(4) and sent to OAH for further proceedings. ALJ Kangas considered claimant's late reopen request, and on February 27, 2025 issued Order No. 25-UI-284469, denying the request and leaving Order No. 25-UI-280258 undisturbed. On March 19, 2025 Order No. 25-UI-284469 became final without claimant having filed an application for review of Order No. 25-UI-284469 with EAB.

On February 17, 2026, OAH returned claimant's February 11, 2025 application for review of Order No. 25-UI-280258 to EAB by operation of OAR 471-040-0040(6). This matter comes before EAB based upon claimant's February 11, 2025 late application for review of Order No. 25-UI-280258.

FINDING OF FACT: (1) Order No. 25-UI-280258, mailed to claimant on January 17, 2025, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 25-UI-280258 at 4. Order No. 25-UI-280258 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before February 6, 2025 to be timely."

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 25-UI-280258 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 25-UI-280258 was due February 6, 2025. Because claimant did not file his application for review until February 11, 2025, the application for review was late. Claimant’s application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the February 6, 2025 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The late application for review filed February 11, 2025 is dismissed. Order No. 25-UI-280258 remains undisturbed.
