

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0168**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On November 26, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant was therefore disqualified from receiving unemployment insurance benefits effective September 28, 2025 (decision # L0014296281). Claimant filed a timely request for hearing. On January 27, 2026, ALJ Naylor conducted a hearing, and on January 28, 2026 issued Order No. 26-UI-318289, modifying decision # L0014296281 by concluding that claimant was discharged for misconduct and disqualified from receiving benefits effective August 10, 2025.<sup>1</sup> On February 17, 2026, Order No. 26-UI-318289 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 19, 2026, claimant filed a late application for review with EAB.

**FINDING OF FACT:** (1) Order No. 26-UI-318289, mailed to claimant on January 28, 2026, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 26-UI-318289 at 4. Order No. 26-UI-318289 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before February 17, 2026 to be timely.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 26-UI-318289 is dismissed.

<sup>1</sup> Although Order No. 26-UI-318289 stated it affirmed decision # L0014296281, it modified that decision by changing the beginning date of the disqualification from September 28, 2025 to August 10, 2025. Order No. 26-UI-318289 at 4. However, the order’s date of disqualification appears to be a scrivener’s error because Order No. 26-UI-318289 found that claimant was discharged by the employer on October 2, 2025 (Order No. 26-UI-318289 at 1) and as such the beginning date of disqualification should have been September 28, 2025, the same disqualification date as on decision # L0014296281.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-318289 was due February 17, 2026. Because claimant did not file his application for review until February 19, 2026, the application for review was late. Claimant’s application for review did not include a written statement describing the circumstances that prevented him from filing the application for review by the February 17, 2026 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

**DECISION:** The application for review filed February 19, 2026 is dismissed. Order No. 26-UI-318289 remains undisturbed.
