

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0178**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On December 19, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and therefore claimant was disqualified from receiving unemployment insurance benefits from November 16, 2025 to February 28, 2026 (decision # L0014803384). Claimant filed a timely request for hearing. On February 11, 2026, ALJ Naylor conducted a hearing, and on February 13, 2026, issued Order No. 26-UI-320299, modifying decision # L0014803384 by concluding that claimant was discharged for misconduct and therefore was disqualified from receiving benefits effective November 16, 2025, and until requalified. On February 23, 2026, claimant filed an application for review of Order No. 26-UI-320299 with the Employment Appeals Board (EAB).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-320299's findings of fact, reasoning, and conclusion that claimant was discharged for misconduct and therefore was disqualified from receiving benefits effective November 16, 2025, until requalified. Order No. 26-UI-320299 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-320299 is affirmed.
