

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0180**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On November 12, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work with good cause and therefore was not disqualified from receiving benefits based on the work separation (decision # L0014264599). The employer filed a timely request for hearing. On February 10, 2026, ALJ Andersen conducted a hearing, and on February 18, 2026, issued Order No. 26-UI-320686, reversing decision # L0014264599 by concluding that claimant voluntarily quit work without good cause, and therefore was disqualified from receiving benefits effective September 21, 2025, until requalified. On February 24, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

**ADOPTION OF HEARING ORDER:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-320686's findings of fact, reasoning, and conclusion that claimant voluntarily quit work without good cause, and therefore was disqualified from receiving benefits effective September 21, 2025. Order No. 26-UI-320686 is **adopted**. See ORS 657.275(2).

**DECISION:** Order No. 26-UI-320686 is affirmed.

**NOTE: Because the initial decision to pay claimant benefits has been subsequently reversed by a decision finding claimant is not eligible for the benefits, claimant may be liable for an overpayment of benefits. Any such overpayment should only be recoverable by deduction from any future benefits payable. However, if claimant is deemed liable for an overpayment, and if paying back the overpayment would be a financial hardship, claimant may request an overpayment waiver. The Department may forgive the debt and stop collection efforts if claimant meets certain requirements. If claimant applies for a waiver but does not qualify for the waiver, other relief may be available. Other relief may include a temporary pause in collection efforts or a limit on how much current benefits may be reduced due to the overpayment. It is important to apply for a waiver as soon as possible because waivers are not retroactive. This means that if the Department grants the waiver, a refund of payments already made on the overpayment will not be received.**
