

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0210**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On August 22, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective June 8, 2025 (decision # L0012460894).<sup>1</sup> On September 11, 2025 decision # L0012460894 became final without claimant having filed a request for hearing. On November 5, 2025 claimant filed a late request for hearing.

ALJ Kangas considered claimant's request, and on January 21, 2026 issued Order No. 26-UI-317627, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 4, 2026. On February 10, 2026, Order No. 26-UI-317627 became final without claimant having filed a response to the appellant questionnaire or an application for review of Order No. 26-UI-317627 with the Employment Appeals Board (EAB). On March 2, 2026, claimant filed a late appellant questionnaire response and a late application for review of Order No. 26-UI-317627 with EAB.

**FINDING OF FACT:** (1) Order No. 26-UI-317627, mailed to claimant on January 21, 2026, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 26-UI-317627 at 2.

<sup>1</sup> Decision # L0012460894 stated that claimant was denied benefits from June 8, 2025 to June 20, 2026. However, decision # L0012460894 should have said that claimant was disqualified from receiving benefits beginning Sunday, June 8, 2025 and until they earned four times their weekly benefit amount. *See* ORS 657.176.

Order No. 26-UI-317627 also stated on its Certificate of Mailing, “Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than February 10, 2026.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 26-UI-317627 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ended. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 26-UI-317627 was due February 10, 2026. Because claimant did not file their application for review until March 2, 2026, the application for review was late. Claimant filed a late response to the appellant questionnaire addressing why claimant filed a late request for hearing on decision # L0012460894, along with additional information related to the merits of decision # L0012460894. Claimant’s application for review, however, did not include a written statement describing the circumstances that prevented them from filing the application for review by the February 10, 2026 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

**DECISION:** The application for review filed March 2, 2026 is dismissed. Order No. 26-UI-317627 remains undisturbed.
