

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0211

Affirmed
Ineligible Week 48-25
Overpayment Repayable by Deduction from Future Benefits

PROCEDURAL HISTORY: On December 17, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work and therefore was ineligible to receive unemployment insurance benefits during the week of November 23, 2025 to November 29, 2025 (week 48-25); and further that claimant was overpaid \$872 in benefits that he was liable to repay under ORS 657.310 (decision # L0014740598). Claimant filed a timely request for hearing. On January 26, 2026, and continued to February 9, 2026, ALJ Murdock conducted a hearing, and on February 11, 2026, issued Order No. 26-UI-320004, modifying decision # L0014740598 by concluding that claimant was not available for work for week 48-25, was therefore ineligible for benefits for that week; and was overpaid \$872 in benefits that he was liable to repay by deduction from future benefits payable under ORS 657.315.¹ On March 3, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

OVERPAYMENT NOTE: Department records show that on March 30, 2026, claimant's overpayment balance in the amount of \$872 was cancelled.² As a result, claimant is no longer liable for the \$872 overpayment.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-320004's findings

¹ Although Order No. 26-UI-320004 stated that it affirmed decision # L0014740598, it modified the decision because it changed the nature of the overpayment from an ORS 657.310 overpayment for which claimant was liable to repay, to an ORS 657.315 overpayment that is recoverable only by deduction from future benefits payable. Order No. 26-UI-320004 at 3-4.

² EAB has taken notice of this fact, which is contained in Employment Department records. OAR 471-041-0090(1) (May 13, 2019). Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the noticed fact will remain in the record. Nothing in this decision should be construed as to impact the Department's cancellation of claimant's overpayment balance.

of fact, reasoning, and conclusion that claimant was not available for work for week 48-25, was therefore ineligible for benefits for that week; and was overpaid \$872 in benefits that he was liable to repay the overpayment by deduction from future benefits payable under ORS 657.315. Order No. 26-UI-320004 is **adopted**. *See* ORS 657.275(2).

DECISION: Order No. 26-UI-320004 is affirmed.
