

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0213

Affirmed
Disqualification

PROCEDURAL HISTORY: On November 4, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits from September 28, 2025 to October 3, 2026 (decision # L0013837400). Claimant filed a timely request for hearing. On February 5, 2026, ALJ Andersen conducted a hearing, and on February 13, 2026 issued Order No. 26-UI-320348, modifying decision # L0013837400 by concluding that claimant quit without good cause and was disqualified from receiving benefits effective September 21, 2025 and until requalified under Department law.¹ On March 3, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted written arguments on March 3 and 24, 2026. EAB did not consider claimant's March 3, 2026 written argument because she did not state that she provided a copy of her argument to the employer, as required by OAR 471-041-0080(2)(a) (May 13, 2019). Additionally, both of claimant's arguments contained information that was not part of the hearing record and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing.² Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing. EAB considered any parts of claimant's March 24, 2026 argument that were based on the hearing record.

¹ Although Order No. 26-UI-320348 stated it affirmed decision # L0013837400, it modified that decision by changing the dates of the disqualification to begin on September 21, 2025 and to end when requalified under Department law. Order No. 26-UI-320348 at 3.

² Some of the new information contained in claimant's March 24, 2026 written argument had been previously submitted as Exhibit 1, which the ALJ excluded from the record because it had not been served on the employer in accordance with OAR 471-040-0023 (August 1, 2004). Claimant should note that providing that information now with her written argument does not cure that procedural defect, even though the argument and accompanying documents were served on the employer. Further, because claimant was permitted to testify to the contents of that information, its exclusion from the record does not unduly prejudice claimant.

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-320348's findings of fact, reasoning, and conclusion that claimant quit work without good cause. Order No. 26-UI-320348 is **adopted**. *See* ORS 657.275(2).

DECISION: Order No. 26-UI-320348 is affirmed.
