

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0218

Affirmed
No Disqualification

PROCEDURAL HISTORY: On October 3, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits beginning August 10, 2025 (decision # L0013177299).¹ Claimant filed a timely request for hearing. On November 7, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for November 19, 2025. On November 19, 2025, ALJ Naylor conducted a hearing at which the employer did not appear, and on November 20, 2025 issued Order No. 25-UI-311520, concluding that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. On November 25, 2025 the employer filed a timely application for review with the Employment Appeals Board (EAB), which was treated as a request to reopen the hearing pursuant to OAR 471-041-0060(4). ALJ Scott considered this request and on March 4, 2026 issued Order No. 26-UI-322273 denying the employer's request to reopen the November 19, 2025 hearing and leaving Order No. 25-UI-311520 undisturbed. This matter returns to EAB for review on the merits of Order No. 25-UI-311520 pursuant to OAR 471-040-0040(6).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 25-UI-311520's findings of fact, reasoning, and conclusion that claimant was discharged, but not for misconduct, and is not disqualified from receiving benefits based on the work separation. Order No. 25-UI-311520 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 25-UI-311520 is affirmed.

¹ Decision # L0013177299 stated that claimant was denied benefits from August 10, 2025 to August 22, 2026. However, decision # L0013177299 should have said that claimant was disqualified from receiving benefits beginning Sunday, August 10, 2025 and until he earned four times his weekly benefit amount. See ORS 657.176.
