

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0224

Affirmed
No Disqualification

PROCEDURAL HISTORY: On November 10, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective September 28, 2025 (decision # L0013990313).¹ Claimant filed a timely request for hearing. On December 16, 2025, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for December 30, 2025. On December 30, 2025, ALJ S. Lee conducted a hearing at which the employer did not appear, and on January 7, 2026 issued Order No. 26-UI-316353, reversing decision # L0013990313 by concluding that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving benefits based on the discharge.

On January 16, 2026, the employer filed a timely application for review with the Employment Appeals Board (EAB) that was treated as a request to reopen the December 30, 2025 hearing pursuant to OAR 471-041-0060(4). ALJ Scott considered the request, and on March 5, 2026 issued Order No. 26-UI-322568 denying the request and leaving Order No. 26-UI-316353 undisturbed. This matter returns to EAB for review of the merits of Order No. 26-UI-316353 pursuant to OAR 471-040-0040(6).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-316353's findings of fact, reasoning, and conclusion that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the discharge. Order No. 26-UI-316353 is **adopted**. See ORS 657.275(2).

¹ Decision # L0013990313 stated that claimant was denied benefits from September 28, 2025 to August 8, 2026. However, decision # L0013990313 should have stated that claimant was disqualified from receiving benefits beginning September 28, 2025 and until she earned four times her weekly benefit amount. See ORS 657.176.

DECISION: Order No. 26-UI-316353 is affirmed.
