

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0236

Affirmed
No Disqualification

PROCEDURAL HISTORY: On October 8, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective June 8, 2025 (decision # L0013262683).¹ Claimant filed a timely request for hearing. On February 25, 2026, ALJ Goodrich conducted a hearing, and on March 5, 2026 issued Order No. 26-UI-322573, reversing decision # L0013262683 by concluding that claimant quit work with good cause and was not disqualified from receiving benefits based on the quit. On March 10, 2026, the employer filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-322573's findings of fact, reasoning, and conclusion that claimant quit work with good cause and was not disqualified from receiving benefits based on the quit. Order No. 26-UI-322573 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-322573 is affirmed.
