

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0240

Affirmed
Disqualification

PROCEDURAL HISTORY: On February 5, 2026, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective December 21, 2025 to September 12, 2026 (decision # L0015908019). Claimant filed a timely request for hearing. On March 13, 2026, ALJ Parnell conducted a hearing, and on March 17, 2026 issued Order No. 26-UI-323932, modifying decision # L0015908019 by concluding that claimant quit without good cause and was disqualified from receiving benefits effective December 7, 2025. On March 20, 2026, claimant filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-323932's findings of fact,¹ reasoning, and conclusion that claimant quit work without good cause and was disqualified from receiving benefits effective December 7, 2025. Order No. 26-UI-323932 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-323932 is affirmed.

¹ The order under review found, based on taking notice from Department records, that claimant did not report receiving earnings for the weeks of November 16, 2025 through January 10, 2026 (weeks 47-25 through 01-26). Order No. 26-UI-323932 at 2. In fact, Department records show that claimant did not report receiving earnings for the weeks of November 16, 2025 through January 3, 2026 (weeks 47-25 to 53-25), but did report \$293 in earnings for week 01-26. It is presumed that the order intended to state that the period of no earnings were weeks 47-25 to 53-25, and that the reference to no earnings for week 01-26 was merely a typographical error.

EAB has taken notice of the facts showing that claimant did not report receiving earnings for weeks 47-25 to 53-25, but did report \$293 in earnings for week 01-26, which are contained in Employment Department records. OAR 471-041-0090(1) (May 13, 2019). Any party that objects to EAB taking notice of this information must send their objection to EAB in writing, stating why they object, within ten days of EAB mailing this decision. OAR 471-041-0090(2). Unless EAB receives and agrees with the objection, the noticed facts will remain in the record.
