

EMPLOYMENT APPEALS BOARD DECISION
2026-EAB-0258

Affirmed
No Disqualification

PROCEDURAL HISTORY: On December 17, 2025, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer claimant for misconduct and disqualified from receiving benefits effective October 26, 2025 (decision # L0014692681).¹ Claimant filed a timely request for hearing. On March 5, 2026, ALJ Murray conducted a hearing and issued Order No. 26-UI-322539, reversing decision # L0014692681 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the discharge. On March 16, 2026, the employer filed an application for review with the Employment Appeals Board (EAB).

ADOPTION OF HEARING ORDER: EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Order No. 26-UI-322539's findings of fact, reasoning, and conclusion that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the discharge. Order No. 26-UI-322539 is **adopted**. See ORS 657.275(2).

DECISION: Order No. 26-UI-322539 is affirmed.

¹ Decision # L0014692681 stated that claimant was denied benefits from October 26, 2025 to October 31, 2026. However, decision # L0014692681 should have stated that claimant was disqualified from receiving benefits beginning October 26, 2025 and until he earned four times his weekly benefit amount. See ORS 657.176.
