

**EMPLOYMENT APPEALS BOARD DECISION**  
**2026-EAB-0263**

*Affirmed*  
*Ineligible Weeks 31-25 through 35-25*

**PROCEDURAL HISTORY:** On October 9, 2025, the Oregon Employment Department (the Department) served notice of administrative decisions concluding that claimant filed her weekly claims late for the weeks of July 27 to August 2, 2025; August 3 to August 9, 2025; August 10 to August 16, 2025; August 17 to August 23, 2025; and August 24 to August 30, 2025, and was therefore not eligible for unemployment insurance benefits for those weeks (decisions # L0013323886, L0013379764, L0013409834, L0013349422, and L0013306824, respectively). Claimant filed timely requests for hearing on those decisions.

On February 20, 2026, ALJ Janzen conducted a consolidated hearing, and on February 23, 2026 issued Orders No. 26-UI-321157, 26-UI-321131, 26-UI-321133, 26-UI-321127, and 26-UI-321136 affirming decisions # L0013323886, L0013379764, L0013409834, L0013349422, and L0013306824 on the merits, respectively. On March 16, 2026, claimant filed applications for review with the Employment Appeals Board (EAB).

EAB combined its review of Orders No. 26-UI-321157, 26-UI-321131, 26-UI-321133, 26-UI-321127 and 26-UI-321136 under OAR 471-041-0095 (October 29, 2006). For case-tracking purposes, this decision is being issued in quintuplicate (EAB Decisions 2026-EAB-0262, 2026-EAB-0261, 2026-EAB-0263, 2026-EAB-0260, and 2026-EAB-0264).

**ADOPTION OF HEARING ORDERS:** EAB considered the entire hearing record, including witness testimony and any exhibits admitted as evidence. EAB agrees with Orders No. 26-UI-321157, 26-UI-321131, 26-UI-321133, 26-UI-321127 and 26-UI-321136 findings of fact, reasoning, and conclusion that claimant filed late reports for the weeks of July 27 to August 2, 2025; August 3 to August 9, 2025; August 10 to August 16, 2025; August 17 to August 23, 2025; and August 24 to August 30, 2025, and was not eligible for benefits for those weeks. Orders No. 26-UI-321157, 26-UI-321131, 26-UI-321133, 26-UI-321127, and 26-UI-321136 are **adopted**. See ORS 657.275(2).

**DECISION:** Orders No. 26-UI-321157, 26-UI-321131, 26-UI-321133, 26-UI-321127 and 26-UI-321136 are affirmed.
